# **Educational Cooperation Agreement**

Guangxi International Business Vocational College of China (hereinafter called Party A)

Rajamangala University of Technology Thanyaburi of Thailand

(hereinafter called Party B)

Collectively called as the Parties

In order to reinforce the cooperation as well as the cultural and educational exchanges between China and the Kingdom of Thailand, the Parties reach the following educational cooperation agreement on the basis of equality and mutual benefit:

### I. Cooperative programs

Overseas students dispatch

Time and numbers of students

Party B agrees to accept the students sent by Party A to conduct a six-month Thai language study in **Rajamangala University of Technology Thanyaburi of Thailand** In 2011, the numbers of students from Party A are 11 and the study will strat from July 14<sup>th</sup>, 2011 to Jan. 13<sup>th</sup>, 2012 (specific date and time can be



adjusted after negotiation by the Parties according to real situation)

#### **Expenses**

The total expenses for this year's six-month abroad study are 39890 Thai Baht, including the tuition fees, the transportation fares from Bangkok International Airport to the campus and the charges for sightseeing and accommodations. The expenses for international air tickets, daily meals, insurance and daily city transportation are excluded.

# Arrangement for students accommodation

Student dormitories will be provided by Party B with 4 to 6 students in one room, equipping with separate bathroom, water heater, bed, cabinet, writing desk and bedclothes. Water and electricity in dormitories are free of charge.

#### Teaching arrangement

Party B should provide independent classes for the students from Party A and conduct teaching according to the teaching plan submitted by Party A by experienced teachers. At the end of all the learning programs, assessments will be given by Party B. Certificates will be awarded by Party B to the students who complete the courses and pass all the exams. The final achievements of all students should be made in a table and send

## Sightseeing and experiencing activities for students

Party B shall arrangement a Thailand sightseeing and experiencing activity for the students. The specific site can be famous scenic spots or historical sites in Thailand, so that the students can have a direct understanding and experience of Thai culture and history. The transportation fares and the tickets for sightseeing shall be borne by Party B, while the extra expenses are paid by the students.

#### Daily management of students

Party B agrees to manage the study, discipline and life of the Chinese students in accordance with Party A's requirement and guarantee the safety of the students during their stay in Thailand. Students' purchase of medical insurance is strongly recommended by Party B. Party B will handle properly and brief Party A timely on any accident. Party A shall assist Party B with student management.

#### Exchange visits by leaders and teachers of the Parties

In order to strengthen mutual understanding and promote cooperation for mutual benefits, the Parties agree to dispatch delegation for regular visiting to the other side. The air tickets shall be borne by the visiting Party.

Dispatch teachers to the other side for teaching, in-service training or conducting cooperative research on the topics of mutual interests according to the need and possibility of the Parties. Related contracts can be made and entered after consultation.

# Short-term cultural and language exchange programs for students

Party B can arrange and send their students to Party A's college for short-term cultural experiencing programs according to specific situation. The major contents include Chinese language learning, scenic spots visiting in Guangxi, Chinese culture experiencing etc.. Specific exchange programs can be made in accordance with Party B's requirement. Students from Party B shall be no less than 20 with a stay of 5 to 30 days. Specific plan and expenses shall be based on the negotiation by Parties.

# Termination and modification of the Agreement

Shall either Party with the intention to modify or terminate the agreement, each Party should notify the other Party one month in advance. Solutions to the problem can be made through friendly negotiation based on the principle of equality and mutual benefit.

# Agreement and its validity

The Agreement shall be printed in four copies with two in English and the other two in Chinese. All the copies are equally valid and either Party keeps two copies respectively. The signing date of this agreement is:
